**Aptitude Test**

1. Aptitude Test will be conducted in Computer Based Test (CBT) mode. Candidates appearing in Aptitude Test are required to secure more than the cut-off marks in all tests of Aptitude Test batteries in order to be considered as suitable. The marks obtained in Aptitude Test by the candidates who are only considered suitable, will be added to marks obtained in 2<sup>nd</sup> stage CBT to prepare the final merit list for the post of ASM/Traffic Assistant. The ratio of 2<sup>nd</sup> stage CBT marks and aptitude test marks shall be 70:30. However, if a candidate scores less than the cut-off marks in any test of Aptitude Test battery, he/she will be eliminated from the selection process for ASM. The candidates may visit the website of this RRB & view a mock-up link for Aptitude Test containing important instructions, test procedure, norms of evaluation etc. provided to guide the candidates appearing in the computer based Aptitude Test.
2. **Candidates for Aptitude Test are required to submit a Medical certificate fulfilling requisite Vision obtained from an Eye Specialist as per proforma (Annexure-IX, attached with e-call letter) at the time of Aptitude Test, failing which they will not be permitted to attend the Aptitude Test.**

**Typing Skill Test**

3. The Typing Skill Test is qualifying in nature and the candidates appearing in Typing Skill Test have to type in the language opted during application viz. 300 words/ 1500 strokes at the minimum speed of 30 w.p.m. in English or 250 words/ 1250 strokes at 25 w.p.m. in Hindi on computer within 10 minutes to qualify in the test else they (except PWD candidates) will be eliminated from the selection process for Sr. Clerk-cum-Typist. Candidates may please go through other important instructions in the e-call letter carefully.
4. PWD candidates who claim exemption from typing Skill Test are required to submit the medical certificate stating “being unable to type” in prescribed proforma (Annexure-VIII, enclosed with e-call letter) issued by a Medical

Board attached to the Special Employment Exchange or by a Civil Surgeon where such a Board does not exist to be produced at the venue itself on the date of Typing Skill Test, failing which they have to undergo the Typing Skill Test on the scheduled date:-

**Cut off marks for other Posts**

5. In view of the fact that most of the candidates, at different merit positions, have given mixed preferences for multiple posts, including the posts involving Aptitude Test/Typing Skill Test, it is not feasible to release the cut off marks for any other post {Commercial Apprentice (Cat. No.1), Traffic Apprentice (Cat. No.2) & Goods Guard (Cat. No.4)} at this stage.

**General Instructions**

6. Candidates may please note that the roll numbers of the shortlisted candidates for Aptitude Test/Typing Skill Test mentioned above may not include roll numbers of candidates being provisionally considered for the posts of Commercial Apprentice (Cat. No.1), Traffic Apprentice (Cat. No.2) & Goods Guard (Cat. No.4) based on their merit and sequence of options.
7. It may be noted that candidates, about eight times the number of modified vacancies have been shortlisted for Aptitude Test/Typing Skill Test primarily to avoid shortfall in the panel and merely calling a candidate for Aptitude Test/Typing Skill Test does not in any way entitle him/her to an appointment in the Railways.
8. The candidature of all above mentioned candidates is purely provisional and subject to their fulfilling the eligibility criteria/conditions in all respects as indicated in the Centralized Employment Notice No. 03/2015, else their candidature is liable to be rejected at any stage of recruitment process. Further, candidature of any candidate featuring in the debar list, will be rejected at any stage.
